#### 1. COMMITTEE ITEMS

#### A. 2021-2022 Budget Preparations

#### Consumer Price Index (CPI)

Mr. Denis Labossiere, Secretary-Treasurer, reviewed the Manitoba CPI rate for the months of September 2019 to August 2020 (1.3%). Mr. Labossiere also reviewed the CPI rate from January 2020 to September 2020, which resulted in an average of 0.7%.

#### Factors That Will Affect the 2020-2021 Budget

Mr. Labossiere spoke to this item and reviewed the memo provided to the Committee. He noted that factors such as:

- Enrollments;
- COVID-19:
- Tax Incentive Grant (TIG) reduction/phase out;
- Provincial Legislation and Guidelines;
- Administration Cap Limits;
- and, Special Requirement Limits

will have an impact on revenues, expenditures and the development of the 2021-2022 Budget.

Discussions took place regarding existing bills and new bills introduced by the Province. Mr. Labossiere reviewed the Inflationary Impact on Budget for 2021-2022 and how it affects the Special Requirement.

#### 2021-2022 Budget Preparation

Mr. Labossiere reviewed the 2021-2022 Budget Preparation memo provided to the Committee. Trustees asked questions for clarification.

Mr. Labossiere also noted that the deadline for Trustee Budget Requests is December 15, 2020, which is a day after the December Board meeting. He suggested that the deadline date be moved to Friday, December 11, 2020. This will allow the Board to review Trustee Budget Requests at the Committee of the Whole Board Meeting on Monday, December 14<sup>th</sup>.

The Committee agreed to bring forward the following recommendation for the 2021-2022 Preliminary Budget Preparation:

#### B. RFP - Supply of CISCO Wireless Access Points

The Secretary-Treasurer reviewed the Tender regarding the Supply of 300 CISCO Wireless Access Points and 300 CISCO software licenses.

The Committee agreed to the recommendation as presented.

#### Recommendation:

That the Tender from BellMTS in the amount of \$313,733.28 (including taxes) to supply 300 CISCO Wireless Access Points and 300 CISCO software licenses funded through the 2020-2021 Operating Budget, be accepted.

#### C. Ameresco Report

The Secretary-Treasurer spoke to this item and noted that this year's Ameresco (facility) report shows \$53.3M in deferred costs required in the next five years. He reviewed the report and the items listed as high priority in the next five years, which amount to \$7.6M, of which \$1.7M would be funded by Brandon School Division and \$5.9M funded by Public Schools Finance Branch (PSFB). He indicated that several of the large capital projects such as roof and heating system replacements are on the Division's 5-Year Capital Plan submitted to PSFB.

#### D. Confirm Payments of Account (October)

The payments of account for the month of October were provided for information.

The reports were accepted as circulated.

#### E. Review Monthly Reports (September)

The Monthly Reports for the month of September were provided for information.

The reports were accepted as circulated.

#### COVID-19 update:

The Secretary-Treasurer provided an update on additional COVID-19 Expenditures that have already been incurred or will be incurred going forward. The Province has requested that divisions keep track of COVID expenditures, and provide monthly reports to the Province. Last year the Division's net savings due to COVID was approximately \$2.1M. That amount must be spent before the Division will receive additional funds from the Province. The Division currently has approximately \$2.2M in undesignated accumulated surplus for which the majority will be used for COVID expenditures.

Trustees asked questions for clarification regarding teachers and students in remote learning. Dr. Marc Casavant, Superintendent/CEO, discussed how the Division is addressing the winter months and mental health, along with initiatives such as the CalmConnect subscription service.

- 5. Arising out of the implementation of Departmental Amendments under Budget 2020, Josh shared that a number of bills that were previously tabled, have been re-introduced. One of the bills formalized was the dissolution of the Public Schools Finance Branch. That mandate will now fall to Crown Services and be separate from the Dept. of Education.
- 6. Josh Watt provided an overview of the launch of the Newcomer Education Coalition and the Winnipeg Indigenous Executive Circle's first annual *State of Equity in Education Report*. The report calls for greater equity and diversity in Winnipeg's education system. The report will be a focal point of the Fall General Meeting.
- 7. Executive considered varying ways to engage with member boards for the remainder of the school year, including both virtual and in-person (where safe to do so).

# FALL MEETINGS & PROFESSIONAL DEVELOPMENT

#### **CODE ORANGE FOR ALL SCHOOLS**



Effective November 2, Manitoba moved to orange level response restrictions at **ALL** schools in Manitoba. What changes are happening as a result of moving to "orange - restricted" level under Manitoba's pandemic response system, across all schools in our province?:

- K-8 students may be offered temporary remote learning for the duration of the restricted level (orange) to create additional space, where required.
- Blended learning (in-class and online) for grades 9 to 12 where distancing cannot be achieved will continue as per status quo.
- Schools must ensure two meters of physical distancing to the greatest extent possible, and adjust classroom space as necessary; excess furniture must be removed from classrooms to create additional space; other spaces within schools must be repurposed to accommodate more distancing (e.g., multipurpose rooms, empty rooms, shared spaces, common areas, and libraries).
- Extracurricular activities are only permitted if all learning and distancing requirements have been met. If these activities continue, established guidelines must be followed and, in the case of sports, participants should maintain distance when not active.

- Teachers and staff who move across cohorts of students, including substitute teachers, are required to wear medical masks. Medical-grade disposable masks have been issued to all schools. N95 masks are not required.
- Indoor choir and the use of wind instruments are not permitted.
- All field trips must be postponed or cancelled.

All other public health measures are still in effect. All affected school divisions are aware of which schools are impacted, and plans have already been set to address the establishment of orange level restrictions for all schools across all communities of Manitoba. # Student Citizenship and AMM George Harbottle Memorial Award





The Manitoba School Boards Association Student Citizenship Awards program for public school students in Manitoba recognizes outstanding young people throughout Manitoba who are active participants in their communities and schools. Seven awards are given annually, one to a student in each of the association's six geographic regions, and one provincial award to a student group.

Each award winner will receive a certificate and monetary prize of \$1000. Students or groups nominated but not selected to receive an individual award will receive a certificate. There are no age or grade restrictions on this award; all students in regular attendance in the K-12 program at a Manitoba public school are eligible.

The Association of Manitoba Municipalities (AMM) will further recognize one of the association's individual award winners by way of the AMM George Harbottle Memorial Award, in recognition of outstanding contributions at the community level. This award consists of \$1000.

The Manitoba School Boards Association Student Citizenship Award recognizes students from Manitoba schools who demonstrate their commitment to the values of citizenship through activities such as:

- volunteer service to the community (i.e. service to health care facilities, senior citizen groups, shelters, day care centres
- 2. involvement in citizenship or character building organizations
- 3. participation in student government programs or activities
- 4. leadership ability to motivate others to actions to benefit the community

The AMM George Harbottle Memorial Award focuses specifically on those contributions that a student has made in the greater community, beyond the school walls.

The seven regionally-based directors who serve on the association's provincial executive will act as the selection committee for the Student Citizenship Awards. Representatives of AMM will select from among the individual winners of the Manitoba School Boards Association Student Citizenship Awards one student to receive the AMM George Harbottle Memorial Award.
