a) Dr. Linda Ross, Chairperson, Board of Trustees, Brandon School Division, January 8, 2020, addressed to the Honourable Kelvin Goertzen, Minister of Education, noting that vaping has become a serious concern in the Brandon School Division. Vaping suspension records for the 2018-2019 and 2019-2020 school years (up to November 12, 2019) were provided for reference. Dr. Ross cited the Canadian Government's Official website, which states that children and youth are especially susceptible to the harmful effects of nicotine, including addiction. Information on the website also speaks to the harmful effects of vaping liquid and the chemicals used for flavour in vaping products. Further, the Canadian Council of Chief Medical Officers of Health called for measures including restrictions on the accessibility and availability of vaping products, and reducing the appeal of products to youth, including plain packaging, health warnings and regulating the sale and marketing of vaping products and flavourings.

Dr. Ross noted that Nova Scotia and Prince Edward Island are leading the way to help restrict the use of e-cigarettes, by making changes such as banning sales of flavoured e-cigarettes and juices and raising the legal age to buy tobacco and e-cigarettes from 19 to 21. Dr. Ross asks that the Provincial Government review and revise, as necessary, the current laws on vaping, as action is required to address this issue. (Appendix 'A')

Mr. David Yeo, Acting Assistant Deputy Minister, K-12 Education Division, Manitoba Education, August 14, 2020, addressed to Dr. Linda Ross, Chairperson, Board of Trustees, responding to Dr. Ross's letter of January 8, 2020, regarding the Brandon School Division's concerns around the use of vaping products by students. Mr. Yeo indicates that Manitoba Education is currently updating the Substance Use/Misuse and Addictions curriculum, which includes nicotine and vaping. Along with current school-based programs designed to address the use of tobacco and vaping products, additional teacher resources are being developed. Mr. Yeo notes that as of December 2019, Health Canada announced new proposed regulations which will further restrict the promotion of vaping products aimed at reducing advertising exposure to youth. Contacts for public health messaging and information on additional resources on vaping are also provided. Mr. Yeo encourages school communities to be proactive in promoting student wellness and thanks the Brandon School Division for raising concerns on this important issue. (Appendix 'B')

According to the Canadian Government Official website, children and youth are especially susceptible to the harmful effects of nicotine, including addiction. They may become dependent on nicotine with lower levels of exposure than adults.

"Nicotine:

- · can affect memory and concentration
- is known to alter teen brain development

"Accepting the Challenge"

Exposure to nicotine during adolescence may cause:

- reduced impulse control
- · cognitive and behavioural problems

Vaping may predispose youth to addiction to nicotine and possibly other drugs. Vaping liquid containing nicotine is poisonous, particularly to young children. Even in small amounts, vaping liquid containing nicotine can be very harmful if:

- swallowed
- absorbed through the skin

There have been fatalities as well as non-fatal nicotine poisoning caused by children swallowing vaping liquid."

"There are health risks linked to other chemicals found in vaping products. Vaping substances have fewer and different chemicals than in tobacco products.

Vegetable glycerine and propylene glycol are the main liquids in vaping products. These are considered safe for use in many consumer products such as cosmetics and sweeteners. However, the long-term safety of inhaling the substances in vaping products is unknown and continues to be assessed.

Chemicals used for flavour in vaping products are used by food manufacturers to add flavour to their products. While safe to eat, these ingredients have not been tested to see if they are safe to breathe in."

"About 15 per cent of the lung injury cases related to vaping in the U.S. have been in those under 18 years old, Schuchat said.

Canada's chief public health officer and all provincial and territorial medical officers of health said they're increasingly concerned by the substantial rise of vaping among Canadian youth. "We cannot stand by and watch a new generation of Canadians become dependent on nicotine or be exposed to products that could have significant negative consequences for their health," the Council of Chief Medical Officers of Health said in a statement."

"They called for measures including restrictions on the accessibility and availability of vaping products, reducing the appeal of products to youth, including plain packaging, health warnings and regulating the sale and marketing of vaping products and flavourings, and putting in place school and community policies to reduce use."

The laws in Canada range greatly from province to province. Alberta currently has no vaping regulations. The Manitoba government's Non-Smokers Health Protection and Vapour Products Act prohibits vaping by people under the age of 18. It also bans vaping in indoor public places like schools, libraries, hospitals, malls, restaurants and indoor workplaces. The province's ban on the advertising and promotion of tobacco products covers e-cigarettes as well.

The following provinces are leading the way to help restrict the use of e-cigarettes:

Nova Scotia

Health Minister Randy Delorey has announced the province will ban sales of flavoured ecigarettes and juices as of April 1, 2020. Nova Scotia banned the sale of e-cigarettes to anyone under 19 in 2015. Vaping is also prohibited in any venue where tobacco smoking is banned, and vape shops are not allowed to display e-cigarette advertising outside their businesses.

Prince Edward Island

The P.E.I. legislature passed a bill in November raising the legal age to buy tobacco and ecigarettes from 19 to 21 — the highest age limit in the country. The legislation also bans certain flavours of e-cigarettes. E-cigarette sales are already banned wherever tobacco sales are prohibited.

Vaping is a serious concern. The Board of Trustees of the Brandon School Division requests that the Provincial Government review and revise, as necessary, the current laws on vaping. Action is required to address this serious issue. We look forward to your response. Thank you for your attention to this matter

Dear Dr. Ross:

On behalf of the Honourable Kelvin Goertzen, Minister of Education, we are responding to your January 8, 2020 letter regarding The Brandon School Division's concerns around the use of vaping products by students. My apologies for the delay in responding.

As you may be aware, Manitoba Education is currently updating the Substance Use/Misuse and Addictions curriculum which includes nicotine and vaping. Along with current school-based programs designed to address the use of tobacco and vaping products such as the Review and Rate program, additional teacher resources are being developed. School divisions also have the opportunity to direct their Healthy Schools Grant funding to substance use prevention programming should they wish.

Manitoba's *Smoking and Vapour Products Control Act,* includes provisions that regulate vaping products in much the same way as tobacco products, these restrictions on the sale, use in public places and display, advertising and promotion are aimed at reducing youth uptake. Health Canada currently regulates vape devices and liquids from a production, content and safety perspective, as well as the distribution, packaging and promotion of vape products. As of December 2019, Health Canada announced new proposed regulations, which will further restrict the promotion of vaping products aimed at reducing advertising exposure to youth. Manitoba is part of the national conversation on vaping at various tables, including the Joint Consortium for School Health and the Tobacco Control Liaison Committee.

SUSPENSION REPORT FOR THE 2019/2020 SCHOOL YEAR

There were seventy-two (72) suspensions reported in the second semester of 2019/2020; one (1) in elementary schools and seventy-one (71) in senior high schools. No suspension reports were received after March 23, 2020 due to School Suspension for COVID-19.

There were two hundred sixteen (216) suspensions reported in the first semester of 2019/2020; twenty-three (23) in elementary schools and one hundred ninety-three (193) in senior high schools.

4. COMMITTEE GOVERNANCE GOAL ITEMS

A. 2019-2020 Financial Audit

Mr. Denis Labossiere, Secretary-Treasurer, provided, for information, the BDO Canada LLP Client and Engagement letters regarding the 2019-2020 Financial Audit, and the Planning Report to the Board of Directors.

The Secretary-Treasurer also reviewed a memo from the Treasury Board Secretariat regarding direction for the 2019-2020 Financial Statements. He advised that the memo will be discussed with the Division's auditors.

A. Tender - Furniture - Maryland Park School

B. Lighting Upgrade Retrofit Projects: Vincent Massey High School and École Harrison

The Secretary-Treasurer spoke to this item, indicating that the Manitoba School Boards Association (MSBA) had funds from the Climate Action Incentive Fund (CAIF) to be distributed to divisions. The Brandon School Division put forth several project proposals in July 2020, and two (2) of those projects were approved. The Division is approved for a total of \$227,214 through CAIF for lighting retrofits at École Harrison and Vincent Massey High School. The Division's net cost to have all the lights updated at these schools is \$34,000 after Hydro rebates and CAIF funding. The deadline for project completion is the end of December 2020.

The Committee agreed to the recommendation as presented.

Recommendation:

That the proposal from Johnson Controls in the amount of \$277,594.20 (plus applicable taxes) for facility lighting upgrades at Vincent Massey High School and École Harrison, funded through the 2020-2021 Operating Budget, be accepted.
