The Acting Chairperson declared Jim Murray to be duly elected by acclamation as Chairperson of the Board for the ensuing year commencing November 1, 2010.

ELECTION OF VICE-CHAIRPERSON OF THE BOARD:

The Acting Chairperson invited nominations for the position of Vice-Chairperson of the Board for the ensuring year, noting that a nominator only was required.

Trustee Sumner nominated Trustee Sefton.

Trustee Karnes nominated Trustee Ross.

The Acting Chairperson invited the newly elected Chairperson, Jim Murray to assume the Chair for the conduct of the remainder of the meeting.

CHAIRPERSON'S REMARKS:

Jim Murray
