Trustee Sefton made the following statement regarding Motion 144/2015, from the December 14, 2015 Board meeting:

During the In-Camera portion of our meeting on December 14, 2015, the Board received a confidential report regarding the salaries and benefits for our Senior Administration and Out-of-Scope employees that are not included in collective agreements. Back on December 8, 2014, the Board approved a proposal from MNP to provide compensation consulting services in regard to a market analysis review. As a result of the recommendations from the MNP report, and also after comparing Senior Administration and Out-of-Scope compensation to other Divisions in Manitoba, the Board unanimously approved motion 144/2015.

Motion 144/2015 provides for compensation increases for our Senior Administration and Out-of-Scope employees. In addition, dental and extended health benefit plans were approved for these employee groups.

Funds for a portion of the costs of this improvement were included in our budget deliberations in February 2015. There is an additional cost of \$163,600 that will be included in the 2016-2017 budget.

2.04 Communications for Action

a) Dagmar Jarvis & Geraldine Whetter, Co-Chairs, Valleyview Centennial School Parent Council, December 10, 2015, addressed to the Board of Trustees, regarding Valleyview Centennial School getting full day every day Kindergarten. They note several benefits of full day every day programming, including: More exposure to role models, language, routines, socialization, communication and fine motor skills; decreasing anxiety and social struggles; promotion of physical health, well-being and self-esteem; regular consistent attendance; earlier understanding of the structure of school – socialization, sharing, turn taking, following directions and cooperation. They note that historically, the initial Kindergarten assessments show a large delay in readiness skills. They note their desire for full day every day Kindergarten is not based solely on assessment numbers but a knowledge and belief that being in Kindergarten full days would increase and benefit the opportunity for Valleyview students to be successful learners and members of the community. They request the opportunity to present their desire for full day every day Kindergarten at an upcoming Board Meeting.

b) Kendra Jaffray, Grade 12 student at Crocus Plains Regional Secondary School, January 4, 2016, addressed to Mr. Mark Sefton, Chairperson, Board of Trustees, noting that she has been granted the honour of attending the Forum for Young Canadians in February 2016 by the Forum Selection Committee and her school. This forum is a national educational program of renown, allowing students from all over Canada to learn about our country's system of government, leadership and citizenship in Ottawa, Ontario. Trustee Murray stated that he is very aware of the advantages of full day every day Kindergarten and thought that the request should be referred to budget day. Trustee Sefton added that it is fair to assume that there will be discussions on budget day regarding full day every day Kindergarten. Trustee Sumner reminded that the Public Budget Consultation will be taking place on February 10, 2016 and the Board Meeting for Public Presentations will be taking place on February 29, 2016 for anyone wishing to make a presentation. - b) Learning Support Services Presentation:

Marnie Wilson, Research, Assessment, and Evaluation Specialist, presented to the Board of Trustees on the Preliminary Exploration of the Longitudinal Impact of Full Day Every Day Kindergarten (FDEDK), highlighting the following:

• External Research has shown that:

FDEDK positively impacts emergent reading skills in particular

- FDEDK positively impacts many social-emotional factors, e.g., attention, positive classroom behaviour, self-regulation, social skills, independent learning, engagement, self-esteem
- FDEDK is especially beneficial for children from low socioeconomic backgrounds
- FDEDK is especially beneficial for children of Aboriginal heritage and children with English as an Additional Language

Research Results Corroborated at BSD:

Kilgore (2002)

- While the FDKinders began Kindergarten behind their Half-Day Kinder (HDK) counterparts on pre-assessment measures, they performed at the same level as their HDK peers by the end of the kindergarten year.
- A study of Edmonton public schools begun in 2000/01:
- It is clear that a full-day kindergarten experience enables children, particularly those from educationally deprived backgrounds, to acquire the skills needed to become emergent readers at least to the point at which they are at par with children from more educationally advantaged communities.

Summary:

- Research suggests that there are some positive short-term and longitudinal effects of FDEDK, especially for students of low SES.
- BSD's short-term (over 1 year) results consistently show that, in June, FDEDK students perform on par with HTK students on phonological awareness, despite starting the year with lower performance.
- Preliminary longitudinal data reveals that, in comparison to schools with historically similar academic readiness, a greater % of FDEDK students are meeting Grade 3 expectations.

• Conclusion:

Preliminary longitudinal evidence suggests that BSD Board of Trustees' decision to implement FDEDK in schools with greater proportions of students displaying lower academic readiness has had long-term benefits. Specifically, FDEDK has been a positive factor that has contributed to closing the achievement gap.

Trustee Sumner asked questions for clarification regarding other studies showing the benefits or lack of benefits of implementing FDED Kindergarten in schools with a high level of academic readiness.

Ms. Wilson responded that research generally shows that positive impacts are particularly strong for students of low socioeconomic backgrounds. The results are inconsistent in students with a high level of academic readiness.

Trustees asked questions for clarification.

Trustee Murray commented that in the past, the Board has shared these reports with the Premier and the Minister of Education and asked if the Board could do that again. He believes that this is powerful information and when this type of data is collected in our Division, that information needs to be shared. Trustee Sefton asked if it was the will of the Board was to share this information with the government. The Trustees agreed they would like to send this report to the Premier and the Minister of Education.

Trustee Ross noted she hopes that Ms. Wilson will try to publish this data as it is really important information to add to what exists now.

Trustee Kruck asked if there has been any consultation with the students who are having the lower scores, as to asking them what difficulties are impacting them? Has there ever been a survey of that population?

Mr. Malazdrewicz, Assistant Superintendent, responded that when looking at the components that refer to senior years or older students, these are reflecting requests for service at school sites. It would be where students are approaching administrators or student support services personnel looking for additional service in areas, or requests from parents in terms of supports for their children.

Trustee Sumner thanked Senior Administration for the response and report they provided regarding his Trustee Inquiry. He asked Mr. Gustafson if he could work with Mr. Labossiere to submit a Trustee Budget Request using the information provided in the report.

That the Board of Trustees maintain the status quo procedure for French Immersion Kindergarten Registration. Secondly, that Kindergarten registration dates be aligned; and the Kindergarten information evenings be scheduled to provide parents with information on Kindergarten programming and the registration process.

Trustee Sefton asked that the rules be suspended to allow Trustees to speak to the motion more than two times. The Board agreed to this request.

Trustee Sumner stated he was disappointed in this motion being brought forward and spoke against the motion.

Trustee Murray agreed with Trustee Sumner and spoke against the motion. He spoke on equity and fairness and read an excerpt from the Equity Policy - 1001.1 and noted he would support a random selection process.

Trustee Kruck supported everything said by Trustee Sumner and Trustee Murray and noted he will not be supporting the motion.

Trustee Bartlette noted that the Division wants to be fair to all of our parents regarding programming, and that he believes in thoughtful consideration, which will work towards eliminating the lineups.

Trustee Sefton stated he will be voting against the motion. He believes that the system as it exists today provides an advantage to those that are already advantaged.

Trustee Bambridge spoke in favour of the motion and noted that there have been two consultations on this matter and that the public would like the process to stay the same.

Trustee Buri agreed with the comments made by Trustee Bambridge and spoke in favour of the motion.

Trustee Ross asked Trustee Bartlette questions for clarification regarding his comments. Trustee Ross stated she will not support the motion and that the current system gives an advantage to people who are already advantaged. She stated that a highly sought after program must be made available to everyone and that the current system already buys into the perception that École Harrison is an elite school.

Trustee Bowslaugh noted that if the Board is denying the content of the Equity Policy, it is setting a poor example. She added that a long-term solution is needed.

Trustee Bartlette spoke to Trustee Ross's comments, and noted that the entire system works on thoughtful consideration. He stated that to take parents who have the presence of mind and the consideration of their child to foreplan, and throw them into the pot and say now you will be equally rewarded like everybody else, would be a social injustice.

Trustee Sumner responded to Trustee Bartlette's comments, and noted he was prepared to bring forwarded a motion regarding a modified random selection process.

Trustee Ross provided comments for clarification on how the random selection process will proceed.

Trustee Bowslaugh noted that there is another French Immersion school, which is O'Kelly School in Shilo.
