- a) Board Briefing on Bill 13 "The Preparing Students for Success Act" (Various Acts Amended).
- b) High School Teacher Prep Time (In-Camera)

Dr. Michaels, Superintendent, provided the Board of Trustees with information regarding the implications for governance with respect to the proposed Bill 13 – "The Preparing Students for Success Act" (Various Acts Amended). The Board agreed they would register to speak to proposed Bill 13 when it was presented to the legislature. Senior Administration was directed to prepare a presentation to the Government regarding the Board of Trustees' questions and concerns relating to the proposed Bill 13.
