WHEREAS Article 27 – Lunch Period of the Collective Agreement states:

"Every teacher shall be entitled to an uninterrupted duty free lunch period (mid-day intermission) of (60) minutes, exclusive of scheduled non-contact time, between 11:00 a.m. and 2:00 p.m. of each school day, unless Brandon Teachers' Association on behalf of a majority of the teachers in a particular school and the administration responsible for that school agree to a different arrangement."

AND WHEREAS Vincent Massey High School Teacher Laura Jonasson has been asked to fulfill a time table in which her scheduled lunch period would be from 10:05am until 11:05am.

NOW THEREFORE, the parties agree on a without precedent, without prejudice basis to a one-time variance on Article 27-Lunch Period for Laura Jonasson as follows:

1) That during the first semester of the 2019-2020 school year Laura may take her lunch period outside the 11:00 a.m. to 2:00 p.m. window prescribed in Article 27-Lunch Period of the Collective Agreement.


Topic: Data to inform full day everyday kindergarten




Summary of Trustee Inquiry

EDI Objectives:




- Assess strengths

5 EDI Domains




- 1. Physical Health & Well-being

- Response to Trustee Inquiry: 2016-2017 EDI data do not continue to support the same schools as being most in need.
- At least 5 of the FDEDK schools continue to demonstrate need.
- Some half-time schools are starting to demonstrate as great or greater need than some FDEDK schools.
- However, we can expand our analysis to provide a more robust picture

Strengths and Limitations of EDI Data




- Robust measurement tool
- Covers a wide range of readiness domains
- Provides national comparisons
- Gathered in middle of kindergarten year
- Teacher evaluations with no training to ensure consistency

Other "Readiness" Data Sources:



- 1. Phonological Awareness Screening Tool (PAST)
 - Captured in early fall
 - Consistent administration
 - Only one aspect of readiness captured
 - Data not gathered on many of the most needy students






Household Demographic Index













- Given the smaller relative difference between the schools in the middle group and the variability within that group, the ranking of the schools in the middle group has the potential to become fluid from year to year
- In other words, the schools that don't have FDEDK and demonstrate the most need may not be the same schools in 1, 2 or 3 years.

The original question: "Do more recent EDI reports continue to support the same schools as being most in need?"

Response to Trustee Inquiry:

When we add the extra measures:

- At least 6 of the FDEDK schools continue to demonstrate a need
- Some half-time schools are starting to demonstrate as great or greater need than some FDEDK schools
- However, given the smaller relative differences between these schools and the variability in their data, the relative level of demonstrated need is not possible to quantify.


Next Year's catchments

New Catchment Area Need Analysis Based on 2 Indices:

- Household Need Index: a score out of 250 based on the degree to which families from a given catchment have the following characteristics (based on the 2016 Canadian Census):
 - 1. low income
 - 2. single parent
 - 3. households without a high school diploma
 - 4. high mobility
 - 5. unemployment
- Student Demographic Need Index: a percentage score based on currently enrolled students living in each catchment area, including the following demographic factors associated with greater need:
 - 1. Indigenous
 - 2. English as an additional language learners
 - 3. children in care



Limitations of the Household Need Index




- Based on 2016 Census data
 - Outdated
 - Especially concerning in areas of considerable development
- The definition of mobility: have moved within the last year
 - Different than student transiency
 - Differentially impacts newer developments, and in such cases, is not necessarily indicative of student need
 - Mitigated by removing this measure and adjusting the Household Need Index to 200.....

Student Demographic Need Index based on New Catchment Areas



- Possible Maryland Park students were identified based on current students' addresses falling within the MP catchment area.
- These students were then removed from the numbers at their current schools.
- With these new "hypothetical" student lists, %'s of Indigenous, EAL, and CFS students were calculated and summed.




Limitations of Student Demographic Need Index



- The Demographic Need Index is based on THIS year's students
 - Next year's kindergarten students are not included
 - · Some students will move
- These enrollment lists are somewhat "hypothetical"
 - Not all students within the Maryland Park catchment area will attend MP



The additional catchment area does not significantly impact the response to the Trustee Inquiry.
