2.01 Presentations For Information

a) Seth Friesen, former Vincent Massey High School student, received recognition for his placement on the AP Calculus AB Exam in May 2015. Trustee Sefton congratulated Seth on his outstanding achievement and indicated that out of 302,000 students who had written the exam worldwide, Seth was one of out of only 12 who achieved a perfect score. When asked what he thought about achieving this score, Seth responded that is was "pretty cool" and added that time management was an issue as he wrote 4 AP exams, played club volleyball out of Winnipeg and also played the piano during that time. Mr. Sefton asked how Seth's math teacher, Jim Hartle, helped him to prepare for the exam. Seth indicated that Mr. Hartle makes students want to come to class. He added that if you work hard it pays off, and to do as much prep work as you can. Trustee Sefton thanked Seth for attending and for his hard work.

He noted there were 423 projects from 22 schools and listed the Brandon School Division Schools represented and the numbers of entries from each school. A total of 38 Special Awards worth \$7,800 were won by Brandon School Division Students. This includes two students, Chace Benson and Lucas Harvey of Crocus Plains Regional Secondary School, being judged Best at the Fair and therefore advancing to the Canada Wide Science Fair in Montreal in May. Congratulations were given to all students who participated.

Trustee Kruck spoke on the MSBA Conference presentation by Sheldon Kennedy speaking on the MSBA online training for Respect in School. He indicated that a list of the top 10 divisions that had trained the most was shared and Brandon School Division was not on the list. He asked if there are any plans for BSD to participate in this training program.

Mr. Malazdrewicz thanked Trustee Kruck for the information and noted he will follow up on this matter. He added that the Division has circulated the information on Respect in School because it is a free training package and Senior Administration will ensure it is getting out to as many people as possible.

Trustee Murray added that there was a session on Saturday morning at the MSBA Convention that was attended by four Brandon School Division Trustees, on the Teachings of Anne Frank. He spoke on the Anne Frank Foundation travelling display and noted this has not yet been done in the prairies. The cost is \$750.00 per month and he believes the impact of this is an important aspect of the education of the Division's young people to understand what this young girl went through in her life. He asked if Senior Administration could pass this suggestion on to High School Principals. Trustee Bartlette and Trustee Kruck both spoke in favour of this idea.

Trustee Buri noted he found the Seven Oaks School Division presentation very interesting.

Trustee Murray indicated he attended the session put on by Trustee Sefton, Guy Roberts and Caroline Blaine regarding the Community Mobilization project in Brandon, and noted he heard nothing but good comments following the presentation. He congratulated Trustee Sefton, Guy Roberts and Caroline Blaine for the work they did on the presentation.
