Trustee Bambridge spoke on the Manitoba School Boards Association's (MSBA) student citizenship award program, noting that the deadline for nominations has been extended to Friday, February 5, 2021.

Trustee Bambridge announced that the Honourable Cliff Cullen is now the Minister of Education, and the Brandon School Division welcomes him into that portfolio and looks forward to working with him.

Point of Privilege:

Trustee Bambridge stated that Monday, January 25, 2021 was the United Nations' International Day of Education. Nine years ago, she attended the world congress on education in South Africa. They started off the congress with seven minutes of silence as the names of people who were fighting for global education and had lost their lives were displayed. Most of the sessions Trustee Bambridge attended were about equity in education, and she added that we are very blessed in Manitoba and in Canada, but there are still huge inequities in education. In many places around the world, children cannot get an education. There are massive numbers of students in refugee camps where

education is just not an option. There are also places in the world where education is based on gender and education is denied. We have places here in our province where students cannot receive a high school education in their communities and they must travel and live elsewhere. We have a long way to go to achieve equity in education. Trustee Bambridge's hope is that someday, these issues do not exist.
