a) Correspondence from Mr. Garth Nichol, Board Chair, Turtle Mountain School Division, April 16, 2019, sent to the Honourable Catherine McKenna, M.P., Minister of Environment and Climate Change, expressing concern and to make a request in regard to the federal carbon tax which was implemented in Manitoba on April 1, 2019. Although the Turtle Mountain School Division Board recognizes climate change as a series concern, one which requires immediate and sustained action for the betterment of the planet and future generations, their concern is the impact the carbon tax will have on their already very constrained budget. Mr. Nichol states that the Turtle Mountain School Division already makes every effort to ensure their bus routes are as efficient as possible, and they have no other means to reduce their fuel consumption. Turtle Mountain School Division is asking that an exemption from the federal carbon tax, similar to the farm fuel exemption, be considered for the transport of school children by public school divisions. Every dollar they spend on the increased cost of operating their school buses is money that they must take from elsewhere in their budget and will, ultimately, disadvantage students. (Appendix 'A')

Dear Madam:

I am writing on behalf of the Turtle Mountain School Division Board of Trustees, we represent a school division in southwest Manitoba. We are writing to express concern and make a request in regard to the federal carbon tax which was implemented in Manitoba on April 1, 2019.

As a school Board we very much recognize climate change as a serious concern, one which requires immediate and sustained action for the betterment of the planet and future generations. We fully understand the need for everyone to do their part to reduce emissions and the carbon footprint. Our concern is the impact the carbon tax will have on our already very constrained budget, with very little available in terms of viable alternatives to reduce our emissions as a school division.

As a smaller rural school division, we operate 20 daily bus routes to transport students to and from school each day. This is our responsibility as a school division, it is not a choice. We also adhere to standards in terms of the means by which we transport our students with certified school buses. Every fuel source currently available to operate school buses, including gasoline, diesel or propane, is subject to the federal carbon tax. We already make every effort to ensure our bus routes are as efficient as possible, and we have no other means to reduce our fuel consumption.

We know a rebate has been established for individuals and households, and we know farm fuel is exempt from the federal carbon tax. We ask that a similar exemption be considered for the transport of school children by public school divisions. Every dollar we spend on the increased cost of operating our school buses is money we must take from elsewhere in our budget and will, ultimately, disadvantage students.

Thank you for considering our request, we look forward to your response.

#### 4. COMMITTEE GOVERNANCE GOAL ITEMS

#### A. SCHOOL CATCHMENTS

Ms. Caroline Cramer, Director Facilities & Transportation, and Mr. Denis Labossiere, Secretary-Treasurer, reviewed the updated Maryland Park School Catchment Area information. The Committee asked questions for clarification, discussed options and provided direction for the Maryland Park School Catchment Information Session.

#### 5. OTHER COMMITTEE GOVERNANCE MATTERS

#### A. Brandon Schools Instrumental Music Association (BSIMA)

The Secretary-Treasurer reviewed a letter he received from BSIMA regarding providing instruments to Grade 8 students. Currently, the following instruments are not available for use by Grade 8 students: flute, clarinet, alto sax, tenor sax, trumpet, and trombone. The instruments need to be purchased or rented from outside sources at higher rates than BSIMA charges to Grade 7 students.

The cost to purchase instruments for Grade 8 band students is approximately \$86,500 of which the BSIMA is able to provide \$20,000 towards the purchase. In regards to expanding the instrument rental program to Grade 8, the committee reviewed the long-term financial impact of BSIMA, the sustainability of equipment replacement cycle, the estimated additional fees collected, the impact on grade 8 band students and the benefits of providing instruments to grade 8 students.

The Committee recommends that \$66,500 from the 2018-2019 budget be allocated to BSIMA to purchase instruments for grade 8 band students.

#### **Recommendation:**

That the amount of \$66,500 from the 2018-2019 budget be allocated to Brandon Schools Instrumental Music Association (BSIMA) to purchase instruments for grade 8 band students and that the Agreement between the BSIMA and Brandon School Division regarding the financial support be approved and the Secretary-Treasurer and the Chairperson are hereby authorized to sign same.

#### B. New Era School - Steam Unit Ventilation Replacement Project

Last night the K-12 Education Review Commission hosted the first of its public workshops at the Caboto Centre in Winnipeg. I am pleased to report that we had approximately twenty trustees in attendance from several rural and metro Winnipeg boards.

Most of the commissioners along with Dr. Avis Glaze were in attendance and participated extensively in engaging and at times intense roundtable conversations on a variety of topics. As I made my way around the room over the course of about two hours, it became very clear that as part of these workshops, the commissioners will be inundated with very meaningful feedback in a very powerful setting.

The purpose of this note is to encourage every MSBA member board to register as many trustees as possible for at least one of the workshops that are remaining. If last night's event is any indication, the education community in Manitoba is coming out loud and clear with feedback for the commission on the focus areas outlined in the discussion paper.

Toward the end of the evening, co-Chair Manness was asked very pointed questions about the commission's perceived inability to connect with our province's Indigenous community and those living in poverty, given the current schedule and locations of workshops. - 2) You can submit a brief to the commission using a template provided at <a href="https://forms.gov.mb.ca/brief-k12-commission/">https://forms.gov.mb.ca/brief-k12-commission/</a> Deadline for submission is May 30, 2019.
- 3) You can send a written submission to the commission that is not a brief (ie: it can be any length you choose and include any visuals or other information you wish for the Commission to receive). Deadline for submission is May 30, 2019.
- 4) If you wish to take part in the public hearings (which are currently scheduled for June, 2019 and which have not yet been posted publicly), you must submit a brief to the Commission. Submitting a brief will not be an automatic placeholder for your board to appear before the Commission. It is therefore best to simply follow-up by email to request a face to face meeting (private meeting) with the Commission, but you can also submit according to all avenues that you or your board wishes to pursue.
- 5) Some boards will be contacted directly by the Commission to inquire as to their availability to meet with the Commission, if they happen to be visiting your region/community. You can indicate your availability by responding directly back to those invitations. Please note that if you are invited to such a meeting, this may be the only opportunity that your board has to meet with the Commission in your region/community. Talking about

Manitoba's K-12 Education Review



#### **Overview**

On January 23, 2019, the Manitoba government announced the appointment of a nine-member Commission to undertake a comprehensive review of the province's K-12 education system. The mandate of the Manitoba Commission on Kindergarten to Grade 12 Education is to "carry out an independent review of the province's K to 12 education system. Its goal will be improving outcomes for students, ensuring long-term sustainability and enhancing public confidence in our education system." Specifically, the Commission will:

- propose a renewed vision for K to 12 education;
- make recommendations that inspire excellence in teaching and learning, and ignite positive, progressive change in existing systems, structures and programs; and
- look at the K to 12 system as a continuum that takes an integrated, lifelong approach to learning, with strong links between early learning, post-secondary education and labour market success.

The Commission will consult with students, parents, educators, school boards, academics, Indigenous organizations, la francophonie, municipal councils, professional organizations, the business community and members of the public from across Manitoba. It has produced a public consultation discussion paper that sets the context for the review, and provides an overview of its mandate and the processes it will be following.

The Commission will also be conducting extensive research and studying best practices in order to fulfill its mandate.

#### **Key Points**

- School boards welcome the opportunity provided by the education review to engage with all Manitobans in an in-depth discussion about the role of public education in our society, and the best ways to ensure its ongoing relevance and strength.
- Our public school system is not static, but is constantly evolving in response to changing education and societal pressures and needs. Today's classrooms are significantly different from those found in schools only a few years ago. Those changes reflect the efforts of responsive and forward-thinking school boards and professional staff.
- The Education Review is looking at our public school system from a provincial perspective. It is seeking to identify approaches or changes that will benefit all students. While there is value in this approach, we need to guard against a one-size fits all view of public education. Student needs vary within a school, and community needs vary across the province. We need to ensure that our public school system retains the flexibility to address those varying needs.

Accountability for student learning** How do we develop a stronger sense of shared accountability for student learning and an understanding that every member of the education team (e.g., principals, teachers, maintenance staff, bus drivers, administration staff) has an important role to play?
- **5. Governance** What governance structures do we need to put in place to make our education system more relevant and better coordinated?
- **6. Funding** How do we ensure that our education system is sustainable, and that it provides equitable learning opportunities for students of all ages?

#### Why should I care about the Education Review?

The answer to this question really depends on who is asking it, because while we all have a stake in public education, that stake differs from person to person and group to group. Below, we have identified a number of key groups that have a stake in public education, and listed some elements that can be incorporated into a response to the question "why should I care?" about the education review. These elements, which can be modified to reflect local circumstances, can be combined into a brief "elevator pitch" that you can have at the ready, no matter who is asking this important question.

#### **Students**

- Students are the experts about what is working and what needs to change in their schools.
- One of the focus areas of the review is governance of public education. Governance is important to students because they need to be able to connect with those directly responsible for running their schools if they are to affect change in those schools.
- The review gives current students a voice in shaping public education, not only for themselves, but for those students who follow them. Education is a social justice issue.

#### **Parents**

- You know what is working and what is not working for your children. Sharing that insight will benefit not only your own children, but all children.
- You know what your children need, academically, socially, and emotionally, and your involvement in the education review will help shape a school system that meets those needs.
- The education review is your opportunity to share your thoughts about student achievement—how it's assessed, how it's reported, and whether it's meaningful to you as a parent.
- Schools serve entire communities as well as individual students. You know your community, its strengths and its challenges. Your input into the education review can help ensure that a renewed K-12 system can continue to be responsive to local, community needs.

# Manitoba's K-12 Education Review



#### Non-parents/residents

- Even if you don't have kids in school, you have a stake in public education, because you depend on a welleducated citizenry.
- Your tax dollars pay for public education, whether you have children in the system or not. The review gives you
  a say in who will decide how those tax dollars are spent—the provincial government, or members of your own
  community.
- Schools serve entire communities as well as individual students. You know your community, its strengths and its challenges. Your input into the education review can help ensure that a renewed K-12 system can continue to be responsive to local, community needs.

#### **Local government**

- Strong schools are a key component of strong communities, attracting people and investment.
- Partnerships between school boards and local governments can benefit all community members—for example, joint investment in infrastructure, technology, or facilities.

#### **Business/business organizations**

- Students are your future employees, and a well-educated workforce is vital to the success of your business. The review gives you an opportunity to shape how we define well educated.
- Vocational programs that include a work experience component are mutually beneficial to students and businesses. Student get the real-world experience that gives deeper meaning to their in-school education, and business owners have a head start on training the next generation of skilled employees they need.
- School systems are large-scale consumers of goods and services. Locally governed school systems know what
  goods and services are available in their own community, and are more likely to utilize those provided by local
  businesses.

#### Elected School Board Trustees and Federal Politicians Connect in Ottawa

**Ottawa, ON:** Over the past two days, the Canadian School Boards Association board of directors has met with Members of Parliament and Senators to discuss the importance of democratic community voice in public education.

The CSBA board of directors came together from across the country to share information with Federal Parliamentarians on the significant roles that school boards play in the delivery of public education, and the relation to mandates under federal jurisdiction. "While it is important to recognize that education is a responsibility for provincial governments, there remains significant alignment between the priorities of school boards and our federal leaders. This includes the protection of democracy and the right to elected representation at the community level," said CSBA President Laurie French. "We have been very fortunate to have meaningful discussions with a number of parliamentarians and policy advisors about the importance of public education and community representation across all levels of government, including school boards."

Since the time of confederation in 1867, school boards and provincial governments have collaborated to ensure the best outcomes for all students. Many areas of such shared responsibility correspond to implementation of federal priorities. Maintaining strong local governance through school boards therefore remains essential to fulfil both provincial as well as federal objectives. Some shared responsibilities for local school boards and Canada's federal government include Indigenous education, minority official language education, supports for newcomer Canadians and refugees, mental health and addictions, and student safety.

"Unfortunately, in some areas of the country there is an increasing erosion of the fundamental rights of Canadians with regard to local democratic voice in public education through local school boards," said Ms. French. "Governance of the education of children and youth in Canada has been entrusted to locally elected trustees across the country by members of the communities they serve. Protecting local voices to ensure local choices through school boards is important for all citizens. We knew it was essential to meet with MPs and Senators to ensure they understand the roles of local school boards, and the important work that school boards achieve in communities across Canada in service of our students."

The CSBA also liaised with federal representatives to highlight the vital importance of protecting democratic rights at every level across the country. Governing school boards have felt their autonomy and flexibility slip away over time as provincial governments have taken more and more control from the local level. This has resulted in the loss of community voice and the ability to serve students.

"It is important to note that the CSBA, provincial associations, and regional school boards are not against change," said Ms. French. "However, we believe strengthening of the public education system needs to be collaborative and in the best interest of students and communities."

The Canadian School Boards Association represents governing school board members from across the country through their provincial associations. CSBA and its members champion collaboration and innovation in public education.
