Given we were not able to meet, Ms. Cramer provided the following responses to questions that were raised at previous meetings.

#### Response to Questions:

- Is it possible to provide patrols at the traffic circle?  
*Ms. Cramer is not aware of patrol protocols at the schools. We will need to look into this further with the City of Brandon and Brandon City Police.*
- How is the city/division addressing the safety & traffic congestion around Maryland Park School?

*As per the traffic study, they believe they have addressed congestions concerns. If when the school opens there are additional issues, we need to ensure the City of Brandon is aware of concerns from citizens.*

- Is it possible to create a walking path (along 1<sup>st</sup> street) and a bridge and access point in the fence from behind the school?  
*Maryland Park School is a walking school meaning everyone in the catchment area is within 1.6 kilometers. While the bridge could provide convenient access to the school, it was not required to meet the walking school criteria.*
