To help ensure that Brandon School Division students have the best possible education, teachers frequently seek to use Third-Party Educational Applications with their students. These apps frequently require students to have accounts, allowing the teacher to differentiate among their students. Creating a student account often involves the disclosure of some of the student's basic personal information.

Some of these apps are also designated as Social Media Applications. Social Media Apps provide avenues for communication, either in a "private" channel (students, parents, and teachers communicating with each other) or in a "public" channel (communication external to BSD).

If I breach any of these rules I may be disciplined and/or lose my ability to access the site as well as lose computer privileges at my school.
4. I understand that anything I post on the site, or any communication I have with other users on the site, whether on a public wall or as a personal message, is not a private communication and may be viewed by my teacher, the School Leader, other students and users of the site.
5. I understand that anything I post on the site may stay available on the internet forever and cannot be deleted.
6. I also understand that I am not required to have an account and to access the site in order to pass my coursework at the school.
